24 On July 25, 2024, this Court entered the Final Approval Order and Judgment Granting Final
25 Approval of Class Action Settlement and Awarding Attorneys' Fees, Costs, and Incentive Award.
26 Plaintiff has filed the Unopposed Motion to Approve Second Distribution to Settlement Class
27 Members and Additional Settlement Administration Costs ("Motion"). Finding that the grounds
28 stated in the Motion support the relief requested,

1 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:**

2 1. The Motion is GRANTED.

3 2. Within 90 days of the is Order, Settlement Administrator shall send checks to Past
4 Accountholders, and Defendant shall issue Account credits to Current Accountholders for the
5 second distribution. Checks shall be valid for 90 days.

6 3. Any remaining Residual Funds from uncashed second distribution checks shall be
7 paid to the previously approved *cy pres* recipient, California Jump\$tar^t Coalition
8 (<https://cajumpstart.org/about-us>), within 30 days of when checks become invalid.


9 4. A declaration of the Settlement Administrator confirming completion of Settlement
10 administration shall be filed within 30 days of the date the Settlement Administrator send the *cy*
11 *pres* payment **and in any event by no later than May 26, 2026.**

12 5. The payment of additional Settlement Administration Costs is approved as follows:
13 (a) 60,939.66 for costs Defendant already paid, which will be reimbursed to Defendant from the
14 Residual Funds; (b) \$44,636.70 for costs already incurred (\$6,645) plus the additional costs
15 (\$37,991.70) necessary to complete the second distribution and to close the Settlement's
16 administration shall be paid to the Settlement Administrator from the Residual Funds.

17 **6. The Non-Appearance Case Review Re: Distribution iset for 3/11/26 is CONTINUED to 6/2/26 at 8:30 am
IT IS SO ORDERED, ADJUDGED, AND DECREED.**
